Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services. They also inform HUD, families served by the PHA, and members of the public of the PHA's mission, goals, and objectives for serving the needs of low-, very low-, and extremely low- income families.

Applicability. The Form HUD-50075-HCV is to be completed annually by HCV-Only PHAs. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers (HCVs) and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, SEMAP for PHAs that only administer tenant-based assistance and/or project-based assistance, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or HCVs combined and is not PHAS or SEMAP troubled.

B.3 Progress Report.

Provide a description of the PHA's progress in meeting its Mission and Goals described in its 5-Year PHA Plan. The FSS program continues to grow with active and graduating participants and escrow savings growth.

The Housing Authority continues to invest in the repair and modernization of rental units at all of our properties. These tasks are tackled during turnover time when the unit is vacant and prior to re-renting the unit to the next tenant. We are placing the most emphasis on updated kitchens and bathrooms, where necessary, energy star appliances, air conditioners, heaters, and low flush and ADA compliant toilets. We also replaced an A/C heat pump at one of our commercial properties on Allegheny St., Bellefonte, PA.

The staff continues to train as needed, attend conferences, and local housing and human services meetings. We have a membership and participate in the Chamber of Business and Industry for Centre County as well. The Executive Director is on the board of directors for the Pennsylvania Association of Housing and Redevelopment Agencies (PAHRA), chairs the PAHRA Scholarship Committee, is active with the Eastern Continuum of Care (CoC) by attending meetings and holding a role on the Funding Committee for the Eastern CoC as a representative from the South Central Region.

We utilize the HCV budget to the fullest extent possible, however, we find ourselves expending more and more HAP dollars in serving less and less participants. Rents to landlords have escalated and, if we don't pay the current market expectations, (within reasonable rent standards) our voucher holders will have less and less opportunities for decent rental units throughout much of Centre County. We have been contacted by HUD about potential shortfall for 2026.
